Notice is given that on Wednesday 29 June 2016, the Cabinet of Knowsley Metropolitan Borough Council (“the Council”) resolved to adopt the following supplementary planning documents (“the Supplementary Planning Documents”):

- Town Centre Uses Supplementary Planning Document
- Trees and Development Supplementary Planning Document
- Householder Development Supplementary Planning Document
- Developer Contributions Supplementary Planning Document
- Prescott Town Centre Masterplan Supplementary Planning Document

The Supplementary Planning Documents supplement the policies of the Knowsley Local Plan and provide consistent guidance for developers on the design of new development in Knowsley. They are a material consideration in decisions on planning applications.

The Householder Development Supplementary Planning document replaces the previous document of the same name, adopted in 2007. The Developer Contributions Supplementary Planning document replaces the Greenspace Standards and New Development Supplementary Planning Document, adopted in 2007, and the Interim Approach to Developer Contributions document, adopted in 2015. These previous documents have been revoked pursuant to Regulation 15 3(b) of the 2012 Regulations.
